# Policy on Religious Education (RE)

#### 1 Aims and objectives

- 1.1 Religious education enables children to investigate and reflect on some of the most fundamental questions asked by people. At Wheatley Hill Community Primary and Nursery School, we develop the children's knowledge and understanding of the major world faiths, and we address fundamental questions concerning, for example, the meaning of life and the existence of a divine spirit. We enable children to develop a sound knowledge not only of Christianity but also of other world religions, especially those that are the main faiths of children within our school. Children reflect on what it means to have a faith and to develop their own spiritual knowledge and understanding. We help the children to learn from religions as well as about religions.
- 1.2 Our objectives in the teaching of RE are, for all of our children:
  - to develop an awareness of spiritual and moral issues arising in their lives;
  - to develop knowledge and understanding of Christianity and other major world religions or value systems adhered to in the UK;
  - to develop an understanding of what it means to be committed to a religious tradition;
  - to be capable of reflecting on their own experiences, and of developing a personal response to the fundamental questions of life;
  - to develop an understanding of religious traditions, and an appreciation of cultural differences in the UK today;
  - to develop their investigative and research skills, in order to hold reasoned opinions on religious issues;
  - to have respect for other people's views, and hence to celebrate diversity in society.

## 2 The legal position of religious education

Our school curriculum for RE meets the requirements of the 1988 Education Reform Act (ERA). The ERA stipulates that religious education is compulsory for all children, including those in the reception class who are less than five years old. The ERA allows parents to withdraw their child from religious education classes if they so wish, although only after they have given written notice to the school governors. The ERA also allows teachers to refuse to teach religious education, but only after they have given due notice of their intention to the school governors. The religious education curriculum forms an important part of our school's spiritual, moral and social teaching. It also promotes education for citizenship. Our school RE curriculum is based on the Durham LA's Agreed Syllabus May 2020, and it meets all the requirements set out in that document. The ERA states that the RE syllabus should reflect the fact that religious traditions in Great Britain are, in the main, Christian, and that it should, at the same time, take account of the teachings and practices of other major religions.

# 3 Teaching and learning style

- 3.1 We base our teaching and learning style in RE on the key principle that good teaching in RE allows children both to learn about religious traditions and to reflect on what the religious ideas and concepts mean to them. Our teaching enables children to extend their own sense of values, and promotes their spiritual growth and development. We encourage children to think about their own views and values in relation to the themes and topics studied in the RE curriculum.
- 3.2 Our teaching and learning styles in RE enable children to build on their own experiences and to extend their knowledge and understanding of religious traditions in a creative way.

- We use their experiences at religious festivals such as Easter, Diwali, Passover, etc. to develop their religious thinking. We try to organise visits to local places of worship, and invite representatives of local religious groups to come into school and talk to the children.
- 3.3 Children carry out research into religious topics. They study particular religious faiths and also compare the religious views of different faith groups on topics such as rites of passage or festivals. Children investigate religious and moral issues either individually or in groups.
- 3.4 We recognise the fact that all classes in our school have children of widely differing abilities, so we provide suitable learning opportunities for all children by matching the challenge of the task to the ability of the child. We achieve this in a variety of ways, e.g. by:
  - setting tasks which are open-ended and can have a variety of responses;
  - setting tasks of increasing difficulty (we do not expect all children to complete all tasks):
  - grouping the children by ability in the room, and setting different tasks for each ability group;
  - providing resources of different complexity, adapted to the ability of the child;
  - using classroom assistants to support the work of individuals or groups of children.

### 4 RE curriculum planning

- 4.1 RE is a foundation subject in the National Curriculum. We plan our RE curriculum in accordance with the LA's Agreed Syllabus. We ensure that the topics studied in RE build on prior learning. We offer opportunities for children of all abilities to develop their skills and knowledge in each unit, and we ensure that the progression planned into the scheme of work offers the children an increasing challenge as they move through the school.
- 4.2 We carry out the curriculum planning in RE in three phases (long-term, medium-term and short-term). The long-term plan maps the RE topics studied in each term during each key stage. The RE subject leader has adapted the exemplar plan from Durham LEA agreed syllabus to ensure curriculum coverage and progression across Easter and Christmas.
- 4.3 Our Progression documents for each year group form our medium-term plans and give details of each unit of work for each term. The RE subject leader keeps and reviews these plans on a regular basis.
- 4.4 The class teacher writes the plans for each lesson and lists the specific learning objectives and expected outcomes. Teachers use the school systems to plan and often discusses them on an informal basis with the RE subject leader. As a commitment to supporting teachers with the short term planning of RE, the RE leader purchased a short term planning pack from Durham LEA (July 2020).

#### 5 The Foundation Stage

- 5.1 We teach RE to all children in the school, including those in the reception class.
- In reception classes, RE is an integral part of the topic work covered during the year. As the reception class is part of the Foundation Stage of the National Curriculum, we relate the RE aspects of the children's work to the objectives set out in the Early Learning Goals which underpin the curriculum planning for children aged three to five.

#### 6 Contribution of RE to the teaching in other curriculum areas

# 6.1 English

RE contributes significantly to the teaching of English in our school by actively promoting the skills of reading, writing, speaking and listening. We also encourage the children to write and record information, in order to develop their writing ability.

6.2 Personal, social and health education (PSHE)

Through our RE lessons, we teach the children about the values and moral beliefs that underpin individual choices of behaviour. So, for example, we contribute to the discussion of topics such as smoking, drugs and health education. We also promote the values and attitudes required for citizenship in a democracy by teaching respect for others and the need for personal responsibility. In general, by promoting tolerance and understanding of other people, we enable children to appreciate what it means to be positive members of our pluralistic society.

6.3 Spiritual, moral, social and cultural development

Through RE in our school, we provide opportunities for spiritual development. Children consider and respond to questions concerning the meaning and purpose of life. We help them to recognise the difference between right and wrong, through the study of moral and ethical questions. We enhance their social development by helping them to build a sense of identity in a multi-cultural society. Children explore issues of religious faith and values and, in so doing, they develop their knowledge and understanding of the cultural context of their own lives.

6.4 We support British Values and share these values with the children. In lessons and life of the school we look for opportunities to refer to British Values.

#### 7 RE and ICT

7.1 ICT enhances RE, wherever appropriate, in all key stages. The children select and analyse information, using the Internet. They also use ICT to review, modify and evaluate their work, and to improve its presentation. Older children can use PowerPoint to help them to make presentations on various topics, such as sacred symbols in different world religions. Younger children can take photographs of the class acting out a Bible story. They can then make a class storybook of it, by adding in speech bubbles and a narrative text. Or, using desktop software, they can create a special book in which each pupil has his or her own page; they also make a cover and binding for the book, and draw up a set of rules for its use.

#### 8 RE and inclusion

- 8.1 At our school, we teach RE to all children, whatever their ability and individual needs. RE forms part of the school's curriculum policy to provide a broad and balanced education to all children. Through our RE teaching, we provide learning opportunities that enable all pupils to make good progress. We strive hard to meet the needs of those pupils with special educational needs, those with disabilities, those with special gifts and talents, and those learning English as an additional language, and we take all reasonable steps to achieve this. For further details, see separate policies: Special Educational Needs; Disability Discrimination; Gifted and Talented Children; English as an Additional Language (EAL).
- 8.2 When progress falls significantly outside the expected range, the child may have special educational needs. Our assessment process looks at a range of factors classroom organisation, teaching materials, teaching style, and differentiation so that we can take some additional or different action to enable the child to learn more effectively. This ensures that our teaching is matched to the child's needs.

- 8.3 Intervention through School Action and School Action Plus will lead to the creation of an Support plan for children with special educational needs. The support plan may include, as appropriate, specific targets relating to religious education.
- 8.4 We enable all pupils to have access to the full range of activities involved in RE. Where children are to participate in activities outside the classroom (a visit to a Sikh temple, for example, that involves a journey), we carry out a risk assessment prior to the activity, to ensure that the activity is safe and appropriate for all pupils.

#### 9 Assessment for learning

- 9.1 Children demonstrate their ability in RE through a variety of different ways. Younger children might, for example, act out a famous story from the Bible, whilst older pupils might produce a PowerPoint presentation based on their investigation of sacred texts. Teachers will assess children's work in RE by making informal judgements as we observe them during lessons. On completion of a piece of work, the teacher assesses the work and gives the child written or verbal feedback to help guide progress. Older children are encouraged to make judgements about how they might improve their work in the future. The teacher will record the assessment at the end of a unit of work on the Assessment sheet in their RE progression document. This information is used to assess the progress of each child, for setting new goals, and for passing information on to the next teacher at the end of the year. It is also used to inform the RE co-ordinator at what level the class are working at, and to inform planning to ensure the level of work is appropriate.
- 9.2 We follow the assessment policy as set out by the LA's SACRE. This sets out the expected level of attainment for pupils at the end of each Key Stage. At the end of a whole unit of work, the teacher makes a summary judgement about the work of each pupil in relation to his or her expected level of attainment. This is recorded in the teacher's assessment sheets. We use these grades as a basis for assessing the progress of the child, and we pass this information on to the next teacher at the end of the year.
- 9.3 Assessments sheets for each unit of work for each year group are collected by the class teacher. On a termly basis a work moderation is carried out of each year group to look at the work of children.

#### 10 Resources

10.1 We have sufficient resources in our school to be able to teach all our RE teaching units. We keep resources for RE in a central store, where there is a box of equipment for each unit of work. There are a number of Bibles in school and a collection of religious artefacts which we use to enrich teaching in RE.

#### 11 Monitoring and review

- 11.1 The coordination and planning of the RE curriculum are the responsibility of the subject leader, who also:
  - supports colleagues in their teaching, by keeping informed about current developments in RE and providing a strategic lead and direction for this subject;
  - gives the headteacher an annual summary report/audit in which s/he evaluates the strengths and weaknesses in RE and indicates areas for further improvement;
  - uses specially allocated time to review evidence of the children's work.

11.2 This policy will be reviewed at least every three years or in accordance with curriculum guidance.
